**MEMORANDUM OF UNDERSTANDING REGARDING EXTENDING THE 2018-2023
COLLECTIVE BARGAINING AGREEMENT**

Through the Amendment, the parties agree to extend the 2018-2023 Collective Bargaining Agreement ("Agreement") through June 30, 2027 with the following modifications:

1. Article VII, Section A, Subsection 1 - Compensation Schedule and Payment

Section A. 1 is amended as follows:

Teacher compensation for the 2024 - 2027 school years shall be paid in accordance to the attached schedules in Appendix A.

The salary schedule will remain at 26 steps.

Section A. 1 is further amended as follows:

Those individuals who are off the salary schedule (MA lane and beyond) will not receive a step increase but will receive a 3.0% pay raise annually during the length of this contract. Those individuals receiving longevity pay under the 2010-2018 contract will continue to receive their longevity pay at the 2017/18 amount and receive a 3.0% pay raise annually for the length of this contract.

2. Article X, Section F. Retirement Incentive Plan for Teachers. Section F.2.a. is amended as follows:

The teacher shall provide written notice in the form provided in Appendix C to the Superintendent of his/her intention to retire and participate in the program four years, three years, two years, or one year prior to the first day of March of their final year of active service, except as provided in subparagraph (c) below.

Teachers who would elect the 2023/2024 school year to be the first year of the retirement incentive under this contract must provide written notice in the form provided in Appendix C to the Superintendent by November 1, 2023.

3. Article XII, Section C. Terms of Agreement. This article is amended as follows:

This Agreement shall be effective July 1, 2023 and shall continue in effect until June 30, 2027.

4. **Appendix A - Salary Schedules.** Appendix A shall be amended to reflect the following increases:

5. **Appendix B - Extra Duty Schedule.** Appendix B shall be amended for the length of this agreement as follows:

The Board and Association agree to form a committee to consider extra duties. The Extra Duties Review Committee shall be comprised of equal representatives of the Board and Association. The Committee's work shall be completed by July 1, 2023.

The Extra Duties Review Committee shall review and assess the following and make recommendations to the Board and the Association on:

- The addition or removal of position types.
- The development of position job descriptions, and
- Allotted hours & days multiplier.

These recommendations shall be provided no later than the Board's May 2023 meeting. In addition, the following increases shall be made to Appendix B:

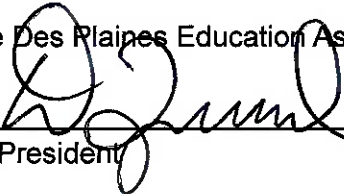

This Amendment is signed this 17th day of January 2023.

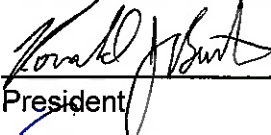

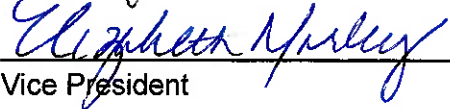
